Pure Ohio Wellness (POW) is a State licensed Ohio based Cannabis company, vertically integrated featuring a Level 1 cultivation facility, Processing/Extraction plant, and multiple dispensaries.

Custodian

We are looking for a responsible custodian to maintain and protect our facilities. As a medical cannabis cultivator, cleanliness is imperative, so this person will be responsible for not only the traditional custodial duties, but also for cleaning and sterilizing the cultivation rooms between plant moves. It is important for a custodian to be careful and thorough in working, cleaning and sterilizing the premises. The ideal candidate will be experienced in a custodian role focused on cleaning. They will have the physical endurance to cover a large space. A keen eye for detail and diligence are also imperative in custodial maintenance jobs. In addition to this, this candidate will have to be willing to learn, understand and follow state compliance regulations.

The Role

- Sweeping, mopping, and vacuuming floors.
- Cleaning and sterilizing cultivation areas prior to a change in inventory.
- Cleaning bathrooms: Washing toilets, sinks, restocking disposable.
- Dusting and wiping surfaces.
- Emptying all trash bins
- Other tasks as needed by management.
- This is a Monday through Friday position. Hours are 11-7pm. ½ hour paid lunch.
- Each candidate will be required to complete a preliminary background screening through Intellicorp at their expense at a cost of \$32.12. If hired, a complete background check through the FBI and BCI are required by the State of Ohio to obtain a license to work in the Medical Marijuana industry.
- Minimum age requirement: 21 years
- Must be able to obtain state approval to work the medical cannabis industry
- Must be able to pass both state and federal background checks free of disqualifying offenses listed in OAC 3796:1-1-014
- Applicant should be self-motivated, hardworking, eager to learn, have excellent people skills, great multi-tasker, and be in good physical condition. Ability to perform certain tasks such as heavy lifting (over 50#), repetitive grasping, standing, bending, and walking (No applicant will be rejected because of a condition or impairment that, with reasonable accommodation, does not prevent performance of work.)
- This is a full-time hourly position. Salary commensurate on management experience. Group health, dental and vision plans available.
